4a (Code:) (Expenses \$ 1,024,832. including grants of \$) (Revenue \$) Kansas City Community Kitchen (KCKK) - provided hot, nutritious meals to those in need at a dining room on the east side of downtown Kansas City located at 750 Paseo, Kansas City, MO. KCKK serves anywhere from 150-550 guests per day.

4b (Code:) (Expenses \$ 161,171. including grants of \$) (Revenue \$) Culinary Cornerstones Training Program (CCTP) - Job training program for the unemployed and underemployed. Guide students to a career in food service and/or catering.

CCTP is a 30-week, 800 hour vocational training program that provides the basic skills for careers in the food service industry. Culinary Cornerstones was created to help resolve greater Kansas City's issues of hunger, homelessness & poverty, specifically under-employment and chronic unemployment. We work with adults willing to do what it takes to turn their lives around after hardship. All students are referred from partner agencies to have the appropriate wrap around services and support that will allow them to succeed.

4c (Code:) (Expenses \$ 143,286. including grants of \$) (Revenue \$) Food Rescue Program - Collected over 600,000 pounds of food from private food retailers and other sources, suitable for re-distribution to the homeless and working poor. Programs include a School BackSnack Program which is a weekend food distribution program operated in partnership with Harvesters, Episcopal Community Services, elementary and middle schools, and area Episcopal parishes that provide food to children enrolled in subsidized school lunch programs.

The Meals on Wheels program delivers hot, nutritious lunches to elderly and disabled individuals who cannot readily leave home. This service is provided 6 days a week, 52 weeks a year.
