Food rescue. Pantries, meal service kitchens, collaboration with local growers and other food access advocates brought fresh produce, small meals, shelf stable food to the nearly 240,000 daily food insecure families and individuals in the five-county area. During 2018 we offered up to 2.5 full-time drivers transporting food from seven different counties to make food available weekly to a network of community partners. The Warehouse Collaborative worked to build a central location to store food and facilitate ongoing access to locally grown food throughout the year with fourteen agencies. Innovative partnerships started in 2017-2018 helped to initiate food security efforts that will continue into 2020.

4b (Code:) (Expenses \$ 943,714 including grants of \$ 0) (Revenue \$ 84,996)

Kansas City Community Kitchen (KCKK). In 2018, over 110,000 people received meals from the efforts of six staff, 25 daily volunteers, culinary students and nearly 85% rescued food. Breakfast and lunch were prepared through a restaurant-style of service and involved the hands-on learning of adult culinary students. During 2018 we served our millionth meal since inception. Other local emergency kitchens continue to visit KCKK to learn best practices, innovative concepts, share resources, and strengthen future collaborations.

4c (Code:) (Expenses \$ 227,912 including grants of \$ 0) (Revenue \$ 1,173)

Culinary Cornerstones Training Program (CTP). This program evolved into the EXPLORERS program for two cohorts during 2018. Underserved individuals were able to gain job training, supports, certifications, and employment through introductory culinary arts education program. During 2018, CTP enrolled 58 adults and 40% of those graduates were successfully employed into the food service industry. Nearly 80% of the participants achieved the ServSafe certification, which is a nationally recognized credential.
